- 1. The price quoted should be F.O.R CSIR-IHBT Palampur, HP.
- 2. The bidder shall attend to the calls for the mentioned items for normal functioning within 1-2 hours after receipt of communication from the Institute. In addition, scheduled preventive maintenance and remedial maintenance for normal functioning of the system shall have to be provided on routine basis.
- 3. No advance payment shall be made. Payment will be made on **quarterly basis** against pre-receipted bill after completion of a quarter. TDS will be deducted as per applicable rules.
- 4. The cleaning of surveillance system and allied equipment should be done on routine basis as per the requirement.
- Bidder should have minimum one-year experience in maintenance of tendered systems and shall submit records on their past experience.
- 6. The successful bidder shall depute an experienced on full time basis to CSIR-IHBT, Palampur, HP.
