



General Guidelines and Application Forms for applying for Research Internship/ Training/ Project Work at CSIR-IHBT, Palampur.

Candidates need to apply through prescribed Application Forms, either (1) or (2) only, based on your eligibility.

Application Form (1) (For candidates pursuing UG/ PG Degree having recommendation from the Institute).

Or

Application Form (2) (For candidates who have completed their UG/ PG Degree; or UG/ PG pursuing candidates without recommendation from the Institute).

How to Submit form:

We accept soft as well as Hard copies of the application.

Kindly submit:

i) Soft copy of the duly filled application form and marksheet of the last examination passed, through e mail to: training@ihbt.res.in (original hard copies are required at the time of joining, if selected).

Or

Send photocopy of the application and self attested copies of requisite documents to: The Coordinator. Training Cell, CSIR-Institute of Himalayan Bioresorce Technology, Post Box-6, Palampur, Himachal Pradesh 176 061.

Note: Kindly bring two Passport size photographs at the time of joining.

Selection Procedure:

After receiving duly filled application along with requisite documents, the application will be shortlisted through a screening process of the Institute and the selected candidates will be intimated through e-mail for joining at CSIR-IHBT, Palampur.

(No. of candidate selected may vary in different batches, depending upon the vacancies/ requirement received from scientists).





Internship/ Project Work/ Training Charges:

Charges for providing lab infra-structure facilities, chemicals, consumable etc. are as follows:

Duration	Charges (Rs.)
Upto 1 month	10,000/-
Exceeding 1 & upto 3 months	15,000/-
After 3 months to 1 year	5000/-per month extra

GST Extra @18% is applicable on above mentioned fee. However, it will be reviewed as per guidelines issued by the Government of India from time to time. However, relaxation in charges is applicable as:

- A concession of 25% towards training charges would be given to trainees from universities having active MoU with CSIR-IHBT.
- A concession of 50% towards training charges would be given to trainees in the subject area of Bioinformatics/ other disciplines where no expenditure is involved towards chemicals at Lab levels.
- The trainees from Universities where students from CSIR-IHBT are registered for their Ph.D. would be exempted from training charges. (Number of students will be accommodated as per the vacancy of the Laboratory).
- 4. The wards of CSIR's employees and ex-employees are exempted from training fee.
- 5. Concessions in training charges may be given on case to case basis after receiving request from economically/ socially weaker sections of society having annual income less than one lakh supported with latest valid income certificate issued by the Revenue Officer not below the rank of Tehsildar. The concessions/ waiver in fee is applicable only for 10 candidates on the basis of first come first serve i.e. from the date of receipt of application in the Institute.
- 6. In case trainee leaves the training within 07 days from the date of start of training, then 75% fee shall be refunded. After that no refund will be given in any case to the trainee.

Note: Training charge is to be deposited after joining the Institute (will be guided at the time of joining) through 'Bank Draft' or 'Banker's Cheque' in favour of "Director CSIR-IHBT, Palampur" or through online mode: Name of Account-Director CSIR-IHBT, Palampur; Bank-State Bank of India; Account No.-30268795419; Branch Code (IFSC Code)-SBIN0003632; MICR Code-176002063.

General Guidelines/ Terms and Conditions:

- 1. Candidate can apply throughout the year.
- 2. Hostel facility is available (double or triple sharing) on payment basis (Rs. 1500.00 per month per person; plus Electricity and Food Charges), based on the availability at the time of joining. Mattress, cot, geyser, fan, table, chair and almirah will be provided in the room. If not interested to opt for hostel facility or non-availability of the hostel rooms, trainees shall have to make their own arrangement for boarding and lodging.





- The research intern/ trainee/ student will have to strictly and mandatorily follow all the norms and guidelines issued by different Central & State agencies and CSIR-IHBT for joining and during training period.
- Upto one-month duration, only certificate will be issued and no project report will be provided.
- Trainee/ parent Institute will not claim any authorship in any publication(s) / patent(s) / IPR / knowhow arising out of work being conducted at CSIR-IHBT, Palampur.

Note: In case of Ph.D./ M.Tech/ M.Pharma students, IPR and publication can be shared based as per CSIR-IHBT guidelines.

Trainee will not publish, upload or circulate any information related to project work (part or whole) in any form (electronic/ print/ social etc.). The data generated/ information received during training at CSIR-IHBT will be used exclusively for compiling project report towards fulfilment of requirements for the degree.

- 6. CSIR-IHBT is the sole custodian of all the data / information generated during training/ internship period and the Institute is fully authorized to use the information as deem fit.
- Trainee will be solely responsible for the safe conduct of experiments in the Institute and shall be abiding by the guidelines / norms of CSIR-IHBT.
- The research intern/ trainee/ student will have to strictly and mandatorily follow all the norms and guidelines issued by different Central & State agencies and CSIR-IHBT regarding any medical or health advisories.
- The trainees will be solely responsible for the safe conduct of experiments in the Institute and shall be abiding the guidelines / norms of CSIR-IHBT during training period.

- 11. Incomplete forms will be not be considered for screening.

- No interim queries will be entertained. Kindly apply at least one month before the proposed date of your training.
- Photography and videography during experimentation/ training will be done in the lab/ fields by CSIR-IHBT and will be used by the Institute for social media, news coverage, other official records and purposes.
